Entitles a couple or a single parent, and their dependent children who have not attained the age of twenty-one (21) to full Club privileges.

Regular Golf **\$2950.00**

Entitles a member who has attained the age of twenty-one (21) to full Club privileges.

Young Professional – Family **\$3687.00**

Entitles a couple or a single parent, (between the age of 21 and 30), and their dependent children who have not attained the age of twenty-one (21) to full Club privileges.

Young Professional **\$2360.00**

Entitles a member who has not attained the age of thirty (30) to full Club privileges.

Couples **\$5383.00**

Entitles a couple who domicile together to full Club privileges.

Junior **\$745.00**

Entitles a member between the ae of twelve (12) and twenty-one (21) to certain golf, clubhouse, and pool privileges. These are defined in the Club Handbook.
