## MEMBERSHIP CATEGORIES

Regular Golf – Family <b>\$6100</b>	Entitles a couple or a single parent, and their dependent children who have not attained the age of twenty-one (21) to full Club privileges.
Regular Golf <b>\$3050</b>	Entitles a member who has attained the age of twenty-one (21) to full Club privileges.
Young Professional – Family <b>\$3812</b>	Entitles a couple or a single parent, (between the age of 21 and 30), and their dependent children who have not attained the age of twenty-one (21) to full Club privileges.
Young Professional <b>\$2440</b>	Entitles a member who has not attained the age of thirty (30) to full Club privileges.
Couples <b>\$5566</b>	Entitles a couple who domicile together to full Club privileges.
Junior <b>\$800</b>	Entitles a member between the age of twelve (12) and twenty-one (21) to certain golf, clubhouse, and pool privileges. These are defined in the Club Handbook. Upon attaining the age of twenty-one (21), the member shall pay any applicable difference in dues and fees for the membership category desired. Potential members who are not children of members must be proposed in accordance with Article 1, Section 5.
Corporate <b>\$6100</b>	Entitles a member to full Club privileges and their guest to four (4) eighteen hole rounds of golf per week, from April 1 <sup>st</sup> through October 31 <sup>st</sup> . The twice per-month restriction applies to guests of Corporate Members.
Associate – Family <b>\$750</b>	Entitles a couple, or single parent, and their dependent children who have not attained the age of twenty-one (21) to clubhouse and pool privileges.
Associate –Family <b>\$300</b>	Entitles a single golf member to add their family as Associate's to their Regular Golf Membership
Associate <b>\$560</b>	Entitles a member who has attained the age of twenty-one (21) to clubhouse and pool privileges.
Social <b>\$150</b>	Entitles a member who has attained the age of twenty-one (21) to clubhouse privileges.
